What is this product?

Type

This product is a share of an investment company qualifying as an undertaking for collective investment in transferable securities (UCITS).

Term

This sub-fund has no maturity date. However, the manufacturer may decide to close the sub-fund under certain circumstances.

Objectives

The objective of the sub-fund is to achieve a return equal to or above that of the bond and credit markets, with an investment grade rating, while enabling investors to contribute to the energy transition. The management policy will also take into account environmental, social and good governance (ESG) criteria in addition to conventional financial criteria for stock selection. The sub-fund has a sustainable investment objective within the meaning of Article 9 of the SFDR.

The sub-fund invests:

- mainly in green bonds aligned with the Green Bond Principles of the International Capital Market Association, these being investment grade and denominated in the respective currencies of OECD member countries;

- on an ancillary basis in other green bond securities aligned with the Green Bond Principles of the International Capital Market Association, total investments in non-investment grade bonds and unrated bonds being limited to a maximum of 10% of the net assets; - in other financial instruments provided for by the investment restrictions, including cash, IMM and/or UCITS/other bond and/or money market UCIs.

A minority share of the assets (up to 33% of its net assets) may include securities of issuers domiciled and/or listed in emerging countries, as well as UCIs/UCITS and/or other instruments authorised under point III.1.A)1.1 of the prospectus with an emphasis on "emerging markets".

Investments in UCITS/other UCIs will be limited in total to a maximum of 10% of the net assets of the sub-fund.

The reference currency of the sub-fund is the Euro. It should be noted that the sub-fund may also invest, without limitation, in assets denominated in currencies other than its reference currency (EURO).

The sub-fund does not use derivatives.

Benchmark: The portfolio is actively managed on a discretionary basis without reference to a benchmark.

Intended retail investor

The sub-fund is particularly suitable for investors with a medium to long-term investment horizon who are looking to benefit from the performance of the bond markets while accepting moderate volatility. Investors should be prepared to accept moderate short-term capital losses due to fluctuations in bond prices.

Other information

Depository: Banque et Caisse d'Epargne de l'Etat, Luxembourg

Dividend income: This class is a capitalisation class meaning that income is reinvested.

Conversion right: The investor has the right to convert his investment in shares in one sub-fund for shares in the same sub-fund or in another sub-fund. The investor can obtain information about how to convert in the prospectus of the fund.

Segregation: The assets and liabilities of a sub-fund are segregated pursuant to the law so that the commitments and liabilities of one sub-fund do not affect the other sub-funds.

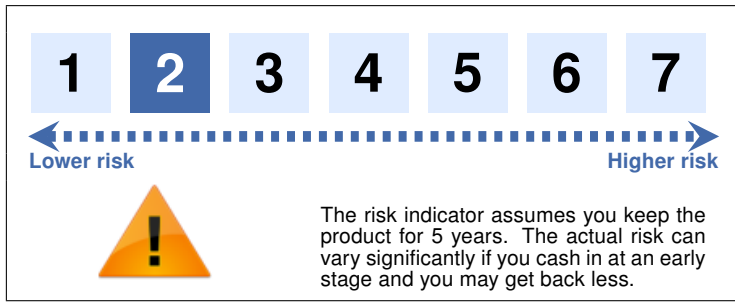

What are the risks and what could I get in return?

Risk indicator



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you.

We have classified this product as 2 out of 7, which is a low risk class. This rates the potential losses from future performance at a low level, and poor market conditions are very unlikely to impact our capacity to pay you.

Be aware of currency risk. You may receive payments in a currency that differs from your reference currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.

The sub-fund is also exposed to the following materially relevant risks that are not included in the summary risk indicator: Liquidity risk, Counterparty risk, Operational risk.

This product does not include any protection from future market performance so you could lose some or all of your investment.

If we are not able to pay you what is owed, you could lose your entire investment.

Favourable scenario: This type of scenario occurred for an investment between August 2014 and August 2019, by referring to a benchmark.

What happens if Spuerkeess Asset Management S.A. is unable to pay out?

If we are not able to pay you out what we owe you, you are not covered by any national compensation or guarantee scheme. To protect you, the assets are held with a separate company, the depositary Banque et Caisse d'Epargne de l'Etat, Luxembourg. Should we default, the investments are liquidated and the proceeds are distributed to the investors. In the worst case, however, you could lose your entire investment.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding period we have assumed the product performs as shown in the moderate scenario
- 10,000 EUR is invested

How long should I hold it and can I take money out early?

Recommended holding period: 5 years

Redemptions are possible on each full bank business day in Luxembourg. In exceptional circumstances, your right to request the redemption of your investment may be limited or suspended.
